I. Call to Order and Opening Prayer

Dave Faber is a guest at the board this evening. Dave speaks to the board to encourage us as a board of limited jurisdiction. Dave speaks about the wonderful and passionate teachers that we have at St. Joseph.

Dave comments that it is encouraging to see enrollment increased at St. Joseph over the past five years. Dave looked at the program effectiveness survey given to parents and staff, and commented that on all 42 questions given to parents, all results were above the average for the diocese. Dave also commented on the high percentage of parents who indicated they would recommend our school to others. Dave comments that he is encouraged to see baptisms for St. Joseph parish are also up.

Dave looked into the survey that the school board completed together, specifically at the results in which the board indicated "not evident" as an answer. One example of this answer concerned the communication between the school board and the diocese. Dave comments on the communication between the school and the diocese through a kickoff event at the beginning of the year, and the board participating in the diocese school board summit each year. Dave indicates that there are many ways that the parish is collaborating with the diocese.

Dave also commented on the board being unsure about if we assessed ourselves. He indicated that the survey the board completes accomplishes this.

Dave shows a video in which Bishop Walkowiak speaks about the new 5-year strategic plan for the diocese.
